

**VILLAGE OF SCHOOLCRAFT
APPLICATION FOR DRIVEWAY / CURB CUT PERMIT**

In accordance with Section 14 of the Village of Schoolcraft Standard Specifications, "Specifications Driveway Openings", no person, except the Village of Schoolcraft, shall construct any driveway opening or curb cut on any street, alley or other public place, without first obtaining a permit. The permit shall be available through the Village Clerk and the fee for each permit shall be paid as provided by resolution of the Council.

Information on stakes shall include the applicant's name, property address and, where applicable, plat lot number. Failure to provide this information may delay issuance of permit.
