c) The memorandum from Village Manager Cheri Lutz regarding 2023/24 Council goals was discussed.

Trustee Rochholz made the following statement:

• He stated the goals presented are goals for both the Council and the Village Manager.

Village Manager Cheri Lutz made the following statements:

- She stated five (5) water lines will be replaced on US 131 during the road project in 2023 or early 2024.
- She stated information about financial aspects on lead line replacement will be presented in January 2024 from Baker Tilly.
- She stated that given the staff shortages in all Village departments, it would be a challenge to begin new large projects.
- She presented a chart on how some of the ARPA funds were dispersed; saying some
 municipalities were late submitting their application and received funding, some received funds
 that didn't submit an application. She questioned why the Village of Schoolcraft didn't receive
 any funds for replacing lead pipes, which is state mandated. An application was submitted in
 a timely manner and was done correctly.

It was the consensus of the Council to assign Village Manager Lutz to write a strategic plan on how to reach each goal and present them at a future meeting.
