- He stated perhaps Rural Development should have been considered for financing.
- He stated this violation is especially disturbing as the amended Articles of Incorporation was approved very recently.

Trustee Carlin made the following statement:

• He stated the SKCFA Finance Committee will meet July 6, 2023 at 8:00 p.m.
