## REPORTS FROM VILLAGE ADMINISTRATION:

- She stated Nonla Taqueria presented their site plan at the last Planning Commission meeting and are scheduled to open the first of November.
- She stated Jamie Clark of Clark Logistics attended the Planning Commission last week to inform the commission of plans for the building on the corner of Cedar and Cass streets.
- She stated that in lieu of writing a letter to South Kalamazoo County Fire Authority regarding the audit and financials, she suggested a council member and a staff member attend one of their meetings.
- She stated that she, President Gunnett and DPW superintendent Coffman looked at where the asphalt was torn up to repair a water main at Mark's Sales and Service. It was decided to reimburse Mark Parker up to 25% of the cost of repaving.

Police Chief Campbell stated that Officer Sheteron has accepted a position at Cass County Sheriff's Department.

Trustee Stodola had the following comments:

- He stated that Adam Smaka from Wightman has calculated new numbers for sanitary sewer and water proposal.
- He stated the chemistry class at Schoolcraft High School has entered a Rural Water Authority contest.
