- a) President Dan DeVries presented the 2011 Citizen Survey to the Village Council with the following comments:

- b) The memorandum from Village Manager Cheri Lutz and Village Treasurer Faith Akert regarding State Revenue Sharing was discussed with the following highlights:
 - The Village of Schoolcraft anticipates a reduction of approximately \$6,000.00 to \$28,000.00 from the State of Michigan due to the proposed elimination of Statutory Revenue Sharing.
 - The Village may be eligible to receive up to approximately 63% of the previous year Statutory Revenue Sharing in a New Program, by meeting specific requirements, to be fully identified by the State, at a later date.

President DeVries thanked the manager and treasurer for their work, and requested a letter be sent to State Senator Jase Bolger addressing the Village's concerns with the proposed plan.

TABULATION OF BIDS:

Mr. Tom Wheat of Prein and Newhof appeared before the Village Council to present bids for the 2011 Street Resurfacing Program.

Motion by Tackett, seconded by Gunnett, to award the bid to Lakeland Asphalt Corp. in the amount of \$45,502.70. All aye.

President DeVries had the following comments:

- He stated that street projects are currently being paid for out of fund balance.
- He stated that the Village Council will need to consider how they will continue to fund street projects in the next few years.
